DONATION AGREEMENT (109)

SECTION I

I, THE UNDERSIGNED (WHO MAY ALSO HEREAFTER BE REFERRED TO AS DONOR) DO HEREBY DONATE THE ITEM, PROPERTY, OR WORK DESCRIBED IN SECTION II BELOW AND IN ANY ATTACHMENTS HERETO (HEREAFTER DONATION) TO PEGASI, A WASHINGTON NONPROFIT CORPORATION (HEREAFTER ORGANIZATION).

I WARRANT AND REPRESENT THAT I OWN THE DONATION, AND THAT NO OTHER PARTY HAS ANY OWNERSHIP CLAIM OR ANY OTHER RIGHTS RELATING TO THE DONATION, AND THAT I HAVE ALL RIGHT AND AUTHORITY NECESSARY TO GRANT FULL OWNERSHIP AND CONTROL OF THE DONATION TO THE ORGANIZATION, AND I HEREBY WAIVE ALL CAUSES OF ACTION AGAINST THE ORGANIZATION THAT ARE RELATED TO THE DONATION OR THIS AGREEMENT.

I DECLARE THAT I DO MAKE SUCH A TRANSFER OF FULL OWNERSHIP, FREE OF ANY ENCUMBRANCES OF ANY KIND, OF THE DONATION TO THE ORGANIZATION, AND THAT I DO SO VOLUNTARY WITHOUT ANY EXPECTATION OF COMPENSATION, AND WITH THE FULL UNDERSTANDING THE ORGANIZATION SHALL USE THE DONATION AS THE ORGANIZATION SEES FIT, IN ITS DISCRETION, WITHOUT ANY LIMITATIONS, AND SUCH USE MAY INCLUDE, BUT IS NOT LIMITED TO SELLING AND USING THE PROCEEDS TO FURTHER THE MISSION OF THE ORGANIZATION, SELLING AND DONATING THE PROCEEDS TO ANOTHER NONPROFIT CORPORATION OR OTHER SIMILAR ENTITY OF THE ORGANIZATION'S CHOOSING.

USE RELATED TO ORGANIZATION FUNCTIONS, OR FOR ANY OTHER PURPOSE AND IN ANY OTHER MANNER. I HEREBY ALSO GIVE PERMISSION FOR THE ORGANIZATION TO PUBLISH OR OTHERWISE RELEASE MY NAME AND DETAILS OF MY EFFORT REGARDING THE DONATION IN ORDER FOR THE ORGANIZATION TO EXPRESS ITS GRATITUDE FOR THE DONATION, AND TO COMPLY WITH ANY GOVERNMENT REQUEST RELATING TO THE DONATION, SUCH AS, BUT NOT LIMITED TO, GOVERNMENT OR TAX REPORTING REQUIREMENTS.

I UNDERSTAND AND AGREE THAT THIS AGREEMENT IS GOVERNED BY THE LAWS OF THE STATE OF WASHINGTON WITHOUT REGARD TO CONFLICT OF LAW PRINCIPLES, AND THAT WASHINGTON IS THE ONLY REASONABLE VENUE FOR RESOLUTION OF CONFLICT. BOTH PARTIES WOULD PREFER A MUTUALLY SATISFACTORY RESOLUTION OF SUCH CONFLICT AND THUS BOTH PARTIES AGREE THAT THEY WILL ATTEMPT TO RESOLVE CONFLICTS THROUGH NON-BINDING CONFIDENTIAL MEDIATION BEFORE TAKING ANY OTHER ACTION REGARDING CONFLICTS.
